Students only wishing to take Jazz, Contemporary, or Modern will need to take a placement class to determine their level. One hour a week is \$85 per month, and two hours a week is \$160 a month.

Recital Fees:

****Recital fee payable by November 15** is \$225 per student if they only need one costume. It is an additional \$60 for extra costumes. **You are responsible for half of the recital fees for the costume if you drop classes after November 15th.** You will receive the costume in the event that you drop classes.

Terms and Conditions: I agree that this is a **9 month contract and tuition is divided evenly over the nine months.** I understand that some months have holidays and some months have 5 weeks, but my tuition is the same regardless. **I understand that there is a 30 day drop policy; if my student decides to drop, I will owe the next month's tuition** (example: if I notify the office at the end of November that I am dropping, I will owe for December). I understand that tuition is due on the 10th of every month and there is a \$20 late fee applied after the 10th. **I understand that May tuition is obligatory, and that it must be paid before I receive my recital tickets.**

We accept credit cards and checks. We do not keep cards on file or take payment over the phone. If you need to pay in cash, you must make arrangements to pay with one of the owners.

Academy of City Ballet of Houston Studio Policies

Dress Code: Skirts, legwarmers, T-shirts, and other cover ups are not allowed as they do not allow the teacher to properly view the dancers' alignment. Ladies wear a black leotard, pink ballet slippers and/or point shoes. Gentleman wear black tights, black ballet shoes, and a white shirt. Tap shoes should be black, and jazz shoes should be nude. **Dancers that are CBH company members may wear a different color leotard in classes**

Financials: There is annual registration fee of \$40 for the first student and \$20 for each additional student due at the beginning of each season. As explained in financial section of this agreement, this is a nine month contract. You may add or drop classes; however, **the 30 day drop policy will apply to your dropped classes**. Late fees are charged for tuition not paid by the 10th of the month, and there is a \$30 returned check fee. All tuition must be paid before receiving recital tickets.

Make up Classes: No refunds or discounts will be given for missed classes; however, you are allowed to make up classes in the same level or the level below. You must notify the desk or send an email to confirm days and times for makeup classes. All makeup classes must be made up before the end of May. We do not carry over makeup classes into the summer.

*****Drop Policy:** A 30 day written notice must be given or emailed to the front desk before dropping a class or dropping out entirely. You will be billed for the next month regardless of whether or not you attend the classes.

Lobby and Parking:

*You may drop your dancer off and pick up if you wish. The person at the desk watches the door.

****Please DO NOT drop your dancer off earlier than a half hour before classes begin WITHOUT ADULT SUPERVISION. We are not a babysitting service and are not staffed to supervise your child during office hours.**

*We ask that there be no running, screaming, or yelling in the lobby or hallways. Parents who have young children not enrolled in classes need to make sure that they are supervised. Staff will address horseplay in the hallway made by unsupervised children.

****Please also be respectful of dancers' bags, balls, rollers, and mats...these are not toys to be played with. Any damage resulting from horseplay will be the responsibility of the parent.**

*Please help keep our studio clean. Be responsible for garbage, dance supplies, clothing, food, and other items.

***Please enter the parking area slowly!** Small children may be exiting the studio, and it is especially difficult to see everyone in the evening.

***Please do not park in front of Building #5 across the street.** If you must park there to wait for your dancer, do not leave your car unattended. The owner will have your car towed.

*Any towing costs incurred by any ACBH customers will not be the responsibility of the studio or its owners.
